How to conduct a vertical analysis of balance sheet?

To conduct a vertical analysis of balance sheet, the total of assets and the total of liabilities and stockholders' equity are generally used as base figures. All individual assets (or groups of assets if condensed form balance sheet is used) are shown as a percentage of total assets.

1. Investor's Lens: - Investors often use vertical analysis to assess the composition of a company's income statement. By expressing each expense category as a percentage of total revenue, they can identify trends and anomalies. - For example, consider a retail company.

How to do a vertical analysis?

The first step of vertical analysis is to make a new income statement, such as the common size income statement stated below. Here, we have divided each item by the company's total sales and shown each category as a percentage of total sales for year 1-3 respectively.

What are the limitations of vertical analysis?

The main limitation of vertical analysis is that vertical analysis sometimes bBy converting each line item into a percentage of a base figure, the method may overlook the nuances and specific details that are critical to a comprehensive financial analysis.

What is a vertical analysis on an income statement?

When we carry out vertical analysis on the income statement, it shows the top-line sales figure as 100% and every other item is shown as percentage of the total sales for that year. Each item in the income statement is divided by the company's total sales for that year (which gives us a common size income statement).
