## **Battery Pack Warranty Period**



What is the warranty period for a battery?

The following warranty periods apply specifically to the USA and Canada. The warranty period is 5 years/2000 charges from the date of purchase, whichever first occurs. The first 1000 charges or 2 years of the warranty, whichever first occurs, are covered through free replacement of the defective battery.

#### What is a battery pack warranty?

In the event energy throughput into (or from) the Battery Pack flows to a 3rd party or whereby such energy is activated or controlled by a 3rd party, the Battery Pack warranty will be limited to 'Fair Usage' levels equal to 10,000 cycles for consumption purposes only at the installed premises.

#### How long is Milwaukee battery warranty?

#### How long is a HP laptop battery warranty?

#### Do I need to register my battery pack to get warranty service?

According to Milwaukee Tool, you do not need to register your battery pack in order to receive warranty service. However, Milwaukee uses the manufacturing date of the product to determine the warranty period if you cannot provide proof of purchase at the time you request warranty service.

#### How long does a lithium battery warranty last?

The warranty start date of lithium batteries cannot be later than six months (outside China) or three months (in China) after the battery delivery date. Scenario 1: Party B is responsible for product installation.
