## What is EU Battery regulation 2023/1542?

Key Provisions and Impact of the New EU Battery Regulatory Explained In July 2023,a new EU battery regulation (Regulation 2023/1542) was approved by the EU. The aim of the regulation is to create a harmonized legislation for the sustainability and safety of batteries.

## What is a waste battery regulation?

Shipment of Waste Batteries: The regulation addresses the shipment of waste batteries outside the EU. Reporting Obligations: Reporting obligations are introduced, and there are specific deadlines for implementing various aspects of the regulation, with certain requirements coming into effect in different phases from 2024 to 2028.

#### Do batteries need a CE marking?

Each category has specific requirements and regulations. CE Marking: Manufacturers will be required to affix the CE marking to batteries before placing them on the market or putting them into service, starting from August 18,2024. The CE marking indicates compliance with EU safety, health, and environmental protection requirements.

### What are battery safety requirements?

These include performance and durability requirements for industrial batteries, electric vehicle (EV) batteries, and light means of transport (LMT) batteries; safety standards for stationary battery energy storage systems (SBESS); and information requirements on SOH and expected lifetime.

#### What are the requirements for a rechargeable industrial battery?

Performance and Durability Requirements (Article 10) Article 10 of the regulation mandates that from 18 August 2024,rechargeable industrial batteries with a capacity exceeding 2 kWh,LMT batteries,and EV batteries must be accompanied by detailed technical documentation.

#### Should portable batteries be removable and replaceable?

Removability and Replaceability: The regulation mandates that portable batteries should be easily removable and replaceable by end-users, while LMT, EV, and industrial batteries should be easily removable and replaceable by independent professionals. This requirement will be enforced from February 18,2027.

The document outlines regulatory requirements for both new energy vehicle manufacturers and battery producers on managing batteries they install and produce.

From August 2024, CE marking will be mandatory for batteries to confirm compliance with the Europe-wide requirements for performance, durability and safety. From February 2027, some ...
