Standard warranties for lithium-ion batteries covering both performance and defects are two years, but extended warranties can be purchased. A warranty beyond 10 years does not make sense because so much of the battery would need to be replaced after year 10. Insurance can also be purchased.

The battery warranty covers only the high voltage battery, and you can"t make a claim unless the battery percentage is less than 70%. If you file a claim, it will not be replaced with a new battery but one with more than 70% remaining. As to the third-party warranty, keep in mind these companies make a fortune on premiums as they collect a lot more than they pay ...

Consult with your installer to choose a battery best suited to your energy needs and existing solar system.
