Can anti-dumping measures be imposed on imports?

If an investigation finds that importers have engaged in dumping and that this has caused injury to the domestic industry of the importing country, anti-dumping measures may be imposed on imports of the product concerned. These measures can take one of the following forms

When a product is considered to be dumped?

A product is to be considered as being dumped if its export price to the Union is less than a comparable price for a like product, in the ordinary course of trade, as established for the exporting country. 3. The exporting country shall normally be the country of origin.

Is a product subject to anti-dumping duties?

In addition to regular customs duties, a product may be subject to anti-dumping duties or other trade defence instruments. Dumping occurs when a company exports a product at a price lower than the product's normal value in its home market. This normal value can be the domestic price of the product or its cost of production.

Is a non-EU company dumping a product?

A non-EU company is 'dumping' if it exports a product to the EU at a price lower than the product's normal value. The normal value is either the product's price as sold on the home market of the non-EU company, or a price based on the cost of production and profit.

What are anti-dumping measures?

Anti-dumping measures counter dumping practicesoccurring when non-EU manufacturers sell their goods in the EU below the normal value (usually the sales price) on their domestic market. A non-EU company is 'dumping' if it exports a product to the EU at a price lower than the product's normal value.

What is anti-dumping duty?
