



# Lithium battery domestic certification

What are the certifications for lithium batteries?

China: The domestic transportation of lithium batteries meets the GB 21966 national standard, and the products need to be CQC certified. United States: Lithium batteries are exported to the United States, with UL, cTUVus, ETL, and NRTL certification options.

What is CCC certification for lithium-ion batteries & battery packs?

CCC certification for lithium-ion batteries and battery packs used in electronic and electrical products will be conducted in the initial phase. For lithium-ion batteries and battery packs used in other electronic and electric products, CCC certification shall be carried out in time when sufficient conditions exist. 3.

What is CSA certification for lithium ion batteries?

CSA certification: Canadian Standards Association certification, applicable to all battery products. CSA C22.2 No.0.15: Safety test standard for lithium-ion batteries. CSA C22.2 No. 107.1: International standard for performance and safety requirements for lead-acid batteries.

Do lithium batteries need to be CQC certified?

Transportation: Lithium primary batteries and lithium ion batteries need to comply with the dangerous goods transportation regulations UN38.3 certification in terms of transportation. China: The domestic transportation of lithium batteries meets the GB 21966 national standard, and the products need to be CQC certified.

Does CCC certify batteries?

Currently, CCC has not implemented compulsory certification for battery cells. However, for products containing batteries, CCC mandates that the batteries must undergo testing related to non-mandatory CQC certification requirements.

Can lithium batteries be exported to the European Union?

European Union: The export of lithium batteries to the European Union requires CE certification and EN/IEC test report. CB member states: Lithium batteries can apply for CB certification and meet the requirements of IEC61960 regulations.

Step 1: Fill in the application form for UN38.3 certification for lithium batteries. Step 2: Sign up with a third-party testing organization for lithium-ion battery products, based on the test items and specific types of lithium-ion batteries.
