

Moldova Energy Storage Project Tender Announcement

The launch, for the first time ever, of tenders for power stations with fixed price will allow building big wind and photovoltaic parks, reducing the dependence on the import of energy, de-carbonizing the economy and creating new jobs. They will also contribute to the fulfillment of Moldova's commitments, in order to reach, by 2030, a share ...

The US government has pledged to make a USD 85-million (EUR 78.3m) investment into Moldova's energy segment by supporting the deployment of large-scale battery energy storage capacity in the Eastern European country.

In the past couple of days developer Akaysha Energy has disclosed a AU\$250 million (US\$163.57 million) debt financing deal, Commonwealth energy minister Chris Bowen revealed huge interest in a tender scheme and state-owned utility Synergy awarded a AU\$160 million contract for work on a 2GWh BESS project.
