Are illegal trade practices injuring the US solar industry?

The petitions allege that "potentially illegal trade practices by Cambodia, Malaysia, Thailand, and Vietnam . . . are injuring the U.S. solar industry" and request that substantial AD and CV duties be placed on all imports from these countries.

Are solar PV manufacturers being forced to work?

And in subsequent years, as regional authorities have intensified repressive policies targeting minoritized peoples, solar PV manufacturers have continued to expand in the region while directly participating in state-sponsored forced labor programs.

Are US solar manufacturers filing AD & CVD petitions?

A group of U.S.-based solar manufacturers have filed AD and CVD petitionswith the U.S. Department of Commerce and the International Trade Commission.

Are US solar companies avoiding tariffs?

The US solar industry is currently bringing more of its manufacturing back to the US,aided by tax credits from the Inflation Reduction Act. The investigation was launched after one small US-based company,Auxin Solar,filed a complaint in February 2022 suggesting that some companies doing business in Southeast Asia might be avoiding tariffs.
