How important is sizing and placement of energy storage systems?

The sizing and placement of energy storage systems (ESS) are critical factors in improving grid stability and power system performance. Numerous scholarly articles highlight the importance of the ideal ESS placement and sizing for various power grid applications, such as microgrids, distribution networks, generating, and transmission [167,168].

Does industry need energy storage standards?

As cited in the DOE OE ES Program Plan, "Industry requires specifications of standards for characterizing the performance of energy storage under grid conditions and for modeling behavior. Discussions with industry professionals indicate a significant need for standards ..." [1, p. 30].
