Will the EU rooftop solar standard drive more rooftop solar capacity?

According to our analysis, the EU Rooftop Solar Standard within the EPBD could drive the installation of 150 to 200 GWof additional rooftop solar capacity in the EU between 2026 and 2030. · Critically, the Solar Rooftop Standard will unlock the potential of large rooftops such as those installed on offices, commercial buildings, or car parks.

Can rooftop solar PV reach a new national target?

But there remains a substantial amount of work to be done to accelerate the deployment of rooftop solar PV to reach the current National target of 3 GW to 5 GW per yearof new capacity set by the 10-year Energy Programme Decree (PPE).

When will rooftop solar be available in Europe?

The president of the European Commission,Ursula von der Leyen,has announced a mandate for rooftop solar on commercial and public buildings by 2027,and for residential buildings by 2029. The EU target for renewable energy has been increased from 40% to 45%.

What is the solar rooftop standard?

The Solar Rooftop Standard will most importantly unlock the potential of large rooftopssuch as those installed on offices, commercial buildings, or car parks. Certain buildings such as agricultural and historic structures may be excluded. Osenberg continues: "Rooftop PV needs to be the gateway to smart electrification.

How big is rooftop solar in Europe?
