Will a 400MW solar PV project be financed by Luxembourg?

Last month the EU announced its inaugural cross-border solar PV tender in the form of a request for proposals (RFP) for 400MW worth of projects to be deployed in Finland, but to be financed by Luxembourg.

Could a solar farm be built in Grimethorpe & Cudworth?

Enviromena is bringing forward proposals for the development of a solar farm on 88ha of land to the north west of the village of Grimethorpe and east of Cudworth. The proposed site is 116 acres of agricultural land located within a designated Special Landscape Area, close to the village of Bentley, Suffolk.

Will the Mallard Pass solar farm take up prime farmland?

The Mallard Pass solar farm - on the Rutland and Lincolnshire border - is the one of the trio approved earlier this month. But the scheme has not been short of detractors, with more than 3,000 people signing a petition opposing the scheme, arguing it would take up prime farmland.

What is the West Burton solar project?

Description: The West Burton Solar Project is named after its proposed grid connection point at the existing National Grid power station at West Burton on the banks of the River Trent in north Nottinghamshire. The project, and its sister project at Cottam, intends to industrialise thousands of acres of farmland in Nottinghamshire and Lincolnshire.

Where is the proposed solar project located?

The proposed site is 116 acres of agricultural land located within a designated Special Landscape Area, close to the village of Bentley, Suffolk. A large solar scheme is proposed for Grendon, Northamptonshire.

Which UK solar farms have been given a green light?

Gate Burton in Lincolnshire, which is more than 1,690 acres in size, and Sunnica's 2,500-acre solar farm on the Cambridgeshire-Suffolk border were both given the green light by Mr Miliband. Labour's manifesto included a pledge to make almost all of country's electricity to be UK-generated and zero carbon by 2030.
