What is the discount rate for a wind project?

For example, the discount rate of an operational onshore wind project over its remaining lifetime would be a high single digit number (7-8%), whereas it is 1% to 2% higher for an investment at ready-to-build (RTB), to pay for the higher construction risk and associated double digit compressed return.

What is a solar tax credit & how does it work?

Currently,the ITC provides a credit on your taxes at 30 percent of the value of your solar project. Notably,the ITC is a tax credit and not a deduction. In other words,if your solar project costs \$100,000,the ITC reduces the amount that you owe the federal government by \$30,000 instead of lowering your taxable income.
