According to TARIC, customs duty for photosensitive semiconductor devices, including photovoltaic cells whether or not assembled in modules or made up into panels; light-emitting diodes, code 8541409000, is 0%. In the HTS tariff system, the duty for solar cells assembled into modules or made up into panels (code 8541.40.60.15) is also 0%.

It allows issuing a certificate of conformity by the certification body. Based on these documents, the manufacturer has the right to issue a declaration of conformity and affix the CE mark on the solar panels. It is also necessary to carry out tests in terms of meeting the EN 1090-1 standard.

Customs and Regulatory Compliance: International shipping of solar panels involves compliance with various customs regulations, import and export restrictions, and quality standards. Familiarity with these regulatory frameworks is critical to avoid delays and legal issues.

For in quota merchandise, use entry type code 02, 06, 07, 12, 23, 32, 38, or 52. For over quota merchandise, use non-quota entry type, e.g., entry type 01. The merchandise covered by the quota may also be subject to antidumping and countervailing duties.
