Why is Brussels scaling back tariffs on Chinese solar panels?

Brussels is scaling back tariffs on Chinese solar panels as it seeks to settle divisions over penalties against Beijing for dumping products on European markets. Two sets of EU tariffs will be extended for 18 months under a decision on Wednesday by the European Commission, which previously wanted to prolong the penalties for two years.

How much does the EU import solar panels from China?

Bilateral trade in goods between the EU and China already well exceeds EUR1 billion per day. In 2012, the EU imported solar panels from China worth about EUR11.5 billion. Regulation to register imports of solar panels from China was published on 5 March 2013 (Publication in the EU's Official Journal).
