Does a warranty cover a new battery?

What is a prorated warranty on a car battery?

With a prorated warranty, you must pay for some of the replacement battery's cost. The battery manufacturer will cover part of the cost of the defective battery. If you have a prorated warranty, you will be reimbursed for the remaining portion if your car battery fails during the warranty period.

Some car batteries may start with a non-prorated warranty for the first 1, 2, 3, or 5 years, referred to as the free replacement period. If your battery fails during this time, you should get a free replacement battery. After that, the battery warranty switches to prorated.

All battery warranties guarantee at least 70 percent battery retention over the warranty period. Model S and Model X battery warranties last 8 years or 150,000 miles, whichever comes first.
