Should compulsory purchases be used for the public good?

Historically, compulsory purchases were carried out under the Inclosure Acts and their predecessors, where enclosure was frequently a method of expropriating people from common land for the benefit of barons and landlords.

What happens if you buy a land if it is compulsorily acquired?

In other words, it will be equivalent to the compensation which would have been payable had the land been compulsorily acquired. This means that in addition to the value of the land, the price may include an amount in respect of severance, injurious affection and disturbance as appropriate.
