## VAT on solar cells



What is the VAT rate for solar panels?

According to the new provisions, member states will be free to apply a VAT rate of 0 to 5% to a restricted list of goods and services, with solar panels now being included in one of the seven categories described in a document related to the proposal.

#### Will 5% VAT be imposed on solar panels?

The European Council has approved a proposal to amend the EU rules on rates of value-added tax (VAT) to give member states more flexibility to set them. If adopted, solar panels for residential and 'public interest' applications would be included in the list of goods and services for which a maximum of 5% VAT could be levied.

### Does VAT apply to photovoltaic systems?

This new paragraph in the VAT Act essentially stipulates that the VAT rate for the supply and installation of certain photovoltaic systems will be reduced to 0%. No VAT will be charged for sales subject to this zero rate. Nevertheless, input tax deduction by the supplier of the photovoltaic system is not excluded.

#### Can 0% VAT be applied to PV systems?

The draft guidance is, overall, to be welcomed. It confirms the hoped-for widest possible application of the 0% VAT rate for the supply of PV systems. The simplification regulations make it easy to apply the 0% VAT rate for modules with an output of between 500 watts and 30 kW (peak) only with few checks.

#### What is the VAT rate for PV systems?

Supply of PV systems: The 0%VAT rate applies to the supply of grid-connected PV systems and stand-alone systems. The rental of PV systems is subject to the regular VAT rate. In the case of leasing or hire purchase agreements, a distinction must be made as to whether this is a supply of goods or a supply of services.

#### Should solar panels be taxed in the EU?

From 1 February 2024, you won"t pay any VAT on batteries for solar panels (previously you had to pay 20% VAT, unless you bought it as part of a solar panel system). So now you can install a standalone energy storage battery or add one to your existing solar PV system, and you"ll pay 0% VAT. From 1 April 2027, this is set to increase to 20% VAT.
